

STATEMENT OF COOPERATION

Finances

- We understand that it is necessary for parents to pay tuition in the amount stated on the *Tuition and Financial Information Statement*.
 - If tuition and fees payments are not received by the 15th of each month, a \$30.00 late charge will be added to the account.
 - Tuition that becomes **30 days past due** will result in your child(ren) being withheld from attending the Academy until the balance is made current.
 - A fee of **\$30.00** will be charged for each returned check.

Volunteers

- To ensure the safety of our students, Arlington Christian Academy has established a volunteer policy outlined in the *Parent–Student Handbook*.
 - We understand that to participate as volunteers, we must abide by the guidelines set forth in that policy and complete any required forms.

Personal Information

- Arlington Christian Academy is committed to protecting your privacy.
 - ACA will use personal information (e.g., email address and phone number) **only for academy-related communication** and will not share, sell, or distribute such information outside of this ministry.

Discipline

- We believe discipline is a necessary part of child(ren)'s education. We give permission for our child(ren)'s teacher and/or administration to make and enforce classroom regulations consistent with Christian principles and biblical discipline.
- Detention may be assigned when necessary, and transportation will be the responsibility of the parents. Written notice will be provided for such assignments.
- Suspension will from the Academy for 3 days at a time will be utilized in extreme cases.
- We understand that we share the responsibility to actively support the authority, philosophy, objectives, policies, procedures, and discipline of the Academy as established by the Governance Board.

School Activities

- We, the parents, give permission for our child(ren) to participate in all academy activities, including class field trips, sports, and school-sponsored trips away from campus. We absolve the Academy of liability for any injury to our child(ren) during such activities.
 - In case of emergency or serious illness, we request that the Academy contact us first. If we are unavailable, please contact our designated emergency contact.
 - If the emergency contact cannot be reached, the Academy has our permission to make whatever arrangements are deemed necessary for our child(ren)'s treatment.
 - If the emergency is life-threatening and we cannot be reached, the attending physician has permission to act accordingly, absolving the school of any liability.
 - This Statement of Cooperation will serve as a **blanket permission slip** for the current school year.

Parental Commitment

- We agree that, if we have a concern or complaint, we will address it directly with the teacher or administration following the **Matthew 18 principle**, rather than discussing it with other parents.
 - We will not post negative or derogatory statements about Arlington Christian Academy, its staff, or its students on any form of social media.
 - We pledge to keep doctrinal controversy out of the Academy and to support the school with our prayers and a positive attitude.
 - We understand that if, at any time, the Academy determines that our actions do not support its mission or reflect a lack of cooperation between home and school, the Academy has the right to request the withdrawal of our child(ren).
 - We understand that the Academy reserves the right to dismiss a student for lack of cooperation on the part of the student, parent, or guardian.
 - Admission to Arlington Christian Academy is a **privilege, not a right**, and is granted with the understanding that students will strive to live as Bible-believing, consecrated Christians.
 - Conduct reflective of developing young Christians is expected. The following are prohibited:
 - Use of alcohol, marijuana, or illegal drugs
 - Smoking, profanity, or disrespect for authority or property
 - Improper sexual behavior
 - Bullying or abuse of others
 - These expectations apply to both academy and non-academy-related activities where behavior could adversely affect the testimony of the school.
 - We acknowledge the **No Bullying Policy** in the *Parent–Student Handbook* and agree to sign the school's *No Bullying Pledge*.
 - As an ACA family, we commit to the biblical principle of the sanctity of marriage between a man and a woman.
